#### 1. Minutes of previous meeting

The minutes of the previous meeting were agreed as an accurate record subject to the following amendment:

Paragraph 4 – development of Springboig/Barlanark Thriving Places – Derek advised that discussions had been ongoing with the anchor organisations even although the funding had not yet been approved.

#### 2. Draft Action Plan

The group was provided with a new format for the action plan which was discussed in detail. The updated plan incorporating all comments is attached.

The process for updating the plan was discussed and it was agreed that this would be circulated to all members at the same time as the call for agenda items. An updated plan would then be issued at each meeting.

THRIVING PLACE

**Action** – Kirsteen to update the Action Plan.

#### 3. Community Engagement Opportunities sub-group

Debbie advised that the sub-group had met earlier this week and had started to pull together an events calendar which could be used to identify opportunities to engage with local residents. It was agreed that 3 gala days over the summer would be used for Thriving Places to engage with residents:

- Glasgow Girls Gala Day at Budhill Park on 4 August
- Wellhouse Gala day no date set yet
- Calvay Gala day July

Banners and flyers would be used to promote Thriving Places and steering group members would be requested to get involved. Jonny agreed to discuss what support the Thriving Places Support Group members could provide at their next meeting. The 3 standard questions in the action plan would be used to gather information from local residents.

It was noted that the engagement opportunities needed to be wider than gala days and the subgroup was requested to consider this and report back on other ways to engage, for example, local schools etc.

It was also agreed the Thriving Place Facebook/Twitter should be used to promote local events.

**Actions**: Derek to link with CPP staff to organise promotional materials

Yvonne to pass the Facebook log in details to Debbie

Engagement sub group to meet to plan for the first event on 4 August

#### 4. Calvay Social Survey

Yvonne advised that Calvay was undertaking a social survey rather than a tenant satisfaction survey this year, the results of which will be shared with the group. This will be wider than Calvay tenants. Jonny was working with Yvonne on the questions which will tie in with the 3 core questions from the action plan and will link with the Performance Management Framework. It will also link with the health and wellbeing survey so that data can be compared. Calvay will also use the information to gain themes for a Community Conference.

#### 5. Easterhouse Job Centre Closure

Jacquie Hughes, Department for Work and Pensions had to submit her apologies for this meeting therefore this item would be deferred to the next meeting. In the meantime Jonny advised that DWP would be delivering training for staff to assist people with the Universal Credit claim process. Craig advised that he would like a member of college staff to undertake this training.

#### 6. Recruitment and Funding Update

A report was issued with the papers providing an update on the agreement between funders and the anchor organisation, the recruitment process and funding for the post.

After discussion, the group

- (1) Noted that the agreement between the funders and the anchor organisation had been drafted and only minor adjustments were required;
- (2) Noted that the Council element of the funding for the post had been approved last week and that the 'call in' period ended on 8 June
- (3) Agreed to use the previous job description and recruitment information with some relevant updates



- (4) Agreed to rename the post to Community Connector to better reflect the role
- (5) Noted that there will already be an underspend in the budget for the Community Connector post and this can be used to support some activity during the year
- (6) Noted that a secondment opportunity to fill the Community Connector post may address the barrier of the short term funding although this depends on who applies and if their employer agrees to it

#### 7. Easterhouse and Springboig/Barlanark Partnership Group

The minute of the meeting held on 23 May 2018 was noted.

Colin Crawford requested that he be added to the mailing list for this group.

Ruth indicated that the former Wise Group buildings at Larchgrove had been sold to Persimmons Homes to build a new luxury flatted development and raised concerns that this could potentially create a 'gated community'. It was noted that if this was the case, a full public consultation would take place as part of the planning process.

She also advised that this would result in the Re-Tune Project requiring new premises. The group suggested that it may be worth Ruth investigating if Re-start in Maryhill had workshop premises that may be suitable. It was also noted that the Area Partnership had provided funding previously for an options study looking at premises within the former East Centre ward. This may also be worth discussing with the Project.

**Action** – Michelle to add Colin to the mailing list for this group.

#### 8. Date of next meeting

It was agreed to cancel the scheduled meeting on 12 July due to the number of apologies received. As the group would not meet again until 23 August, it was agreed that any steering group member interested in being involved with the consultations at the gala days be invited to attend the community engagement opportunities sub-group meetings.

**Action** – Jenny/Debbie to extend an invitation to all steering group members to attend the subgroup metings over the summer period.

# **Background**

1. ## I Community Benefits - Background

**Community Benefits** - Glasgow City Council is committed to maximising the economic, social and environmental benefits from its procurement activity. This is achieved through the inclusion of specific Community Benefit clauses which are used to secure wider benefits in addition to the core purpose of the contract including, but not limited to:

- Targeted Recruitment and Training outcomes
- Educational Support
- Vocational Training
- Business Support
- Community Engagement

Within the CPU we currently have 2 Community Benefit Officers and we offer support to suppliers to get the best for the city out of their CB clauses. As part of this we would like to link our suppliers into some of the activities of the Thriving Places communities. In particular, where they have committed some capacity under the following option we think we could derive some real benefit:

Non-financial support for a community project (CCE02) - This output relates to Community Engagement that does not have a monetary value and may be intangible. Typically the benefits of this output may include: improved capacity and capability, transfer of technical knowledge, upskilling, changes in attitude or enhancement of physical areas. Community Engagement must be evidenced by a report from the supplier and the Community Group of the benefits realised as a result of the intervention received. To be counted as a Community Benefits outcome, the supplier must commit to the provision of a minimum of five hours of community support per outcome offered. Innovative and creative activities are encouraged. Outputs counted for this intervention include but are not restricted to:

- Community Engagement Events
- Community facilities and hardware investment (i.e. Digital Inclusion)
- Regeneration projects involving Community groups, tenants associations and local stakeholders.
- Awareness and Training of Community Groups.
- Professional advice to communities
- Considerate Contractors
- Enhancing health and wellbeing in community
- Fuel poverty initiatives
- Volunteering opportunities for a minimum of 3 days
- Other

There are 15 hours available through community benefits for the Springboig area which can be used at any time for any purpose. GCC Procurement section is looking to identify a relevant local organisation that can be linked with to receive support using these hours.
