1. Welcome and Introductions

Councillor Kelly welcomed everyone along to the meeting and introductions were made around the table.

 Note of Meeting held on 24<sup>th</sup> August 2018 The note of the meeting on 24<sup>th</sup> August 2018 was agreed as an accurate record.

### 3. Community anchor organisation update

A report had been circulated by Derek confirming that Platform had withdrawn from the role as Thriving Place anchor organisation for Easterhouse and that this, together with the vacancy in Springboig & Barlanark, had led to the Chairs of both Thriving Places Steering Groups approaching Glasgow Kelvin College.

The group was asked to consider appointing the College as the Thriving Place anchor organisation for Easterhouse (the Springboig & Barlanark group had already agreed to this). Ruth stated that the HSCP would prefer there to be a process where other interested organisations could express an interest in becoming the anchor organisation, however the other partners present were supportive of the College being appointed and, after some discussion, this was agreed. The group agreed that the position could be evaluated when funding was renewed or if other organisations expressed an interest.

It was agreed that Derek and Craig would discuss actions that had been previously assigned to Platform as the anchor organisation and report back to the group at the next meeting.

Ruth suggested, and the group agreed, that a local person should be involved in the interviewing panel and after some discussion, Maureen agreed to take part.

#### 4. Chance to Change Charrette

David provided a verbal update to the group on the 'Chance to Change Charrette: Easterhouse' report that was presented to the GCC Neighbourhoods, Housing and Public Realm City Policy Committee on 21 August 2018. A copy was circulated around the table and a link is provided <u>here</u>.

This links the Charrette report and action plan to a Section 75 Agreement (capital funding) which is available to develop the area outlined within the designated Easterhouse Town Centre boundary and by the production of the Greater Easterhouse Strategic Development Framework.

The Steering Group would continue to play a part in the delivery of the Charrette action plan and informing the allocation of the Section 75 money. The group noted that Cllr Kelly was seeking wider Thriving Places regeneration investment linked to the Section 75 money and delivery plan.

#### 5. Community Hub Proposal

Jenny circulated a proposal to establish a community hub within the old Savers unit in the Lochs Shopping Centre. The proposal involves initial set up costs for refitting the unit to create a community space (where the Thriving Places Community Connector could have a base) and a discount shop which would be run by Chest Heart Stroke Scotland (CHSS). CHSS will consider a 5 year commitment to run the unit (subject to its Board's approval) if initial costs can be found. It would run on a similar basis to the hub they operate in Drumchapel Thriving Place.

The proposal contained costs of £50,000, with £20,000 being met by Platform and HSCP.

The Steering Group agreed:

- That the proposal was worth pursuing
- It would not be appropriate to use the remaining Thriving Places resources to refit the unit
- City Property, at a senior level, should be contacted for its view Cllr Kelly agreed to make contact
- There was a discussion on the capital funding set aside for Easterhouse Town Centre (Section 75 funding) – Cllr Kelly agreed to write to the Executive Director of Regeneration and the Economy in GCC to ask if this funding, or any other budget within DRS, could appropriately be used to contribute to the refit of the unit.

- That Derek would look to identify other potential funding sources within the Council
- That Ruth would develop a business case for investment for the hub and that partners were welcome to contribute to this

## 6. Funding

Derek discussed a report that had been previously circulated on the funding available to the Steering Group in 2018/19. £28,902 remained unallocated.

Jenny circulated a proposal to produce a Community Newspaper for the Thriving Places area.

The Steering Group:

- Allocated £6,500 for the Community Newspaper
- Noted that, with Glasgow Kelvin College taking on the anchor organisation role, up to £17,500 would be required to fund a Community Connector for the remainder of 2018/19
- The £12,000 set aside at the previous meeting to commission a local organisation to undertake a number of tasks should be discussed with the College and potentially re-allocated.

## 7. Thriving Places Action Plan

The action plan was circulated and an update was provided by Derek on opportunities for participatory budgeting in the future.

Jenny updated on the plans for Winterfest 2018 which required to be scaled back to a 1 day event. Platform would lead on the planning of Winterfest subject to funding being secured for the event. The indicative cost for the event was £5,600 including £3,500 for a Christmas tree. Cllrs Kelly and Burke agreed to look at other ways of securing a tree for the event. Therefore, the Steering Group allocated £2,100 towards Winterfest and suggested Platform also apply for funding from the North East Area Partnership if further funds were needed.

Other action points had been covered earlier in the agenda or related to the Charrette action plan which was to be discussed further at a meeting on 17<sup>th</sup> October 2018.

### 8. Date of Next Meeting

20<sup>th</sup> November 2018 at 10am. The Chair suggested meeting in the Drumchapel Thriving Places hub (see item 5 above) and Jenny agreed to discuss with CHSS.
