Item 1 – Welcome

The Chair opened the meeting and welcomed members.

Item 2 – Minute of Last Meeting

The Executive Group noted the minute of meeting as an accurate record.

Item 3 – City Centre Taskforce

Jane Laiolo provided a presentation on the City Centre Taskforce, including the City Centre Recovery Plan. Glasgow City Centre was significantly impacted by the pandemic and mitigation measures, which brought to the fore some weaknesses in the design and operation of the city centre. Research indicates that Glasgow was the hardest hit city in the UK by the pandemic in terms of economic damage.

Glasgow has secured £1.95m from the Scottish Government to improve the City Centre, and public partners will work with private owners to determine best use of this spend. Particular areas identified for investment include:

- Sauchiehall Street
- Argyle Street
- Anderston
- Heilanman's Umbrella
- Buchanan Bus Station

This investment will compliment the ongoing work of the City Centre Strategy including:

- Strategic Interventions
- Operational Interventions
- Public Transport
- Marketing & Events
- Media

Jane provided details on the next steps for the City Centre Taskforce.

During discussion Jehan asked if there were opportunities to learn lessons from other cities. Jane advised that London Boroughs provide learning opportunities, and consultants are hired, in-part, due to the experience they can bring from other cities/towns. The longer term projects of the City Centre Taskforce have full research elements as part of the plans.

Heather suggested that Jane ask/encourage the Consent Team within HES to do a site visit if they haven't already done so. This will allow HES to see the bigger picture, and the stark picture of the City Centre. HES are working with partners including the City Heritage Trust for Doors Open Day which has driven footfall in the past, and with Glasgow Life with regards the St Mungo's Museum and surrounding area. Heather also suggested that the return of theatres, and including them in wider promotion campaigns, could drive footfall to the City Centre.

Tressa asked that accessibility is at the forefront of decision making for the Taskforce. GDA members have experienced policies that are working against each other, including climate policies that have reduced accessibility. Jane advised that the Avenues Forum have led on the accessibility aspect of projects, and Jane would look into using this forum to inform decision making in other areas of the City Centre. Bernadette suggested that the Glasgow Equalities Working Group could be used to facilitate engagement.

Shaw asked where the pre-pandemic strategy of increasing the residential population of the City Centre would fit post-pandemic. Jane advised that the aim is to double the population of the City Centre to 40,000 by 2035, and good progress is being made on this, however partners are increasingly aware that they could be more aspirational for future targets. Increasing construction costs will impact on this, as will vacant site availability. A large scale increase in City Centre population will require refurbishment of existing buildings.

Item 4 – Transforming Participation for Disabled People in Glasgow

Tressa Burke and Richard Brunner provided a presentation on the recommendations on the Transforming Participation for Disabled People in Glasgow report.

The factors which create barriers to disabled people's participation in decision making was outlined, including quotes from attendees of the co-design events which put these factors into perspective.

The report findings indicated 3 levels of participation:

- Micro-level
- Macro-level
- Meso-level

Finally, the 8 priority recommendations were detailed and discussed by partners.

During discussion the Executive Group agreed to progress this area of work once partners had discussed the recommendations within their own organisation.
